201904-1	<u>Chair</u> to write to India and Spain <u>in April</u> , notifying them that they must pay into the common fund in 2019 to avoid being struck off the list of Contracting Parties from 2020, subject to agreement with IEA Legal that this is the correct procedure.	Incomplete. The ESC decided to not write officially to Spain while discussions are ongoing over potential involvement at Annex level. The IEA Secretariat asked that the letter to India be not sent while discussions over broader Indian engagement with IEA activities continued. The IEA Secretariat are helping the TCP to make new connections at the Indian Bureau of Energy Efficiency.
201904-4	<u>DSM TCP Secretariat</u> to produce a short flyer to succinctly communicate the benefits of joining the TCP; <u>timing to align with the communication</u> <u>of any new name for the TCP</u> .	Complete . (Ongoing at time of writing, but being prepared with LVDI, the company that won the competition to redesign the TCP's visual identity and logo, ahead of the launch of the Users TCP).
201904-8	ESC to prepare a paper on membership rule, fee structure and terms of participation for consideration by the ExCo before the next ExCo meeting .	Delayed to coincide with discussions over updated Implementing Agreement.
201904-9,10,13 & 17	Countries X,Y and Z and Sponsor A to investigate the possibility of participation in the Annex on as soon as possible.	Complete although difficult to assess.
Action 201904-22	<u>ExCo members</u> to provide suggestions for future DSM University webinars to the Operating Agent <u>before the next ExCo meeting</u> .	Ongoing. Only one suggestion received so far.

Review of EUWP feedback

- 1. The EUWP expressed support for the approach taken.
- 2. They agreed with our mission, vision and approach.
- 3. They actively supported our aim to extend our membership, including to emerging/developing countries saying it should enable the TCP to successfully collaborate with the entire IEA community marrying technical with socioeconomic expertise on joint projects.
- 4. They congratulated us on the work we had carried out this year saying it had set the base for a potentially impactful and successful TCP.
- 5. However they said the TCP should consider expanding its scope of work from a fresh perspective without limiting the scope based on the current group of participants.
- 6. They reinforced that tasks should be designed with policy impact in mind.
- 7. They emphasised the desirability of collaboration with other TCPs.

They have recommended to CERT that we be granted a five year extension to our mandate from 1 March 2020 to 28 February 2025.
